In 2020, the US-based fundraising office of Panzi Hospital and Foundation, Panzi Foundation USA (PFUSA) continued to provide strong financial support to support survivors of sexual violence in the Democratic Republic of Congo. This support was made possible by individual contributions from major donors and grassroots supporters, as well as through significant grant funding. Panzi implements a four-pillar holistic healing model that combines comprehensive, compassionate medical treatment with access to psychosocial support, socio-economic reintegration activities, and access to legal services. With PFUSA's financial support, Panzi was able to initiate and continue a number of important projects on the ground in DRC, including but not limited to: mobile clinics and rapid response missions to treat survivors in last-mile communities; after-care services for survivors; capacity-building for the staff; direct support for services rendered at the hospital; and COVID-19 preparedness, testing, and treatment. In addition, PFUSA participated in a number of advocacy-related initiatives focused on peacebuilding and transitional justice and in the DRC, and continued its collaboration with its sister organization, the European-based Mukwege Foundation, to further promote an end to sexual and gender-based violence in the DRC and around the world.

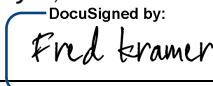
